Our WASH/BLISS Program provided 12 safe water access points for seven villages including wells for three schools benefiting about 4,700 students. The wells were deeper than in the past ranging from 34 to 130 meters. 2,000 liter capacity tanks and submersible pumps were also installed in three of the wells. One of our most important wells was drilled for Mir Hazar village providing access to water to 2,000 people. This was a 120 meter deep well with a submersible electric pump and 5,000 liter capacity tank plus pipeline connection to the other side of the village. - Continued on Schedule O -
